Zhejiang Energy Hong Kong Holding Limited is deemed to have an interest in 430,000,000 Shares held by Raffles Nominees (Pte.) Limited. Zhejiang Energy International Limited owns the entire issued and paid-up share capital of Zhejiang Energy Hong Kong Holding Limited.

Prior to 23 December 2024, Zhejiang Provincial Energy Group Co., Ltd. and Zheneng Capital Holdings Co., Ltd. owned 71.22% and 28.78% of the equity interests in Zhejiang Energy International Limited, respectively.

Accordingly, prior to 23 December 2024, Zheneng Capital Holdings Co., Ltd. was deemed to have an interest in the Shares in which Zhejiang Energy Hong Kong Holding Limited has an interest by virtue of Section 4 of the Securities and Futures Act 2001.

On 23 December 2024, the entire 28.78% equity interest held by Zheneng Capital Holdings Co., Ltd. in Zhejiang Energy International Limited was transferred to Zhejiang Zheneng Fuel Group Co., Ltd..

Each of Zheneng Capital Holdings Co., Ltd. and Zhejiang Zheneng Fuel Group Co., Ltd. is a wholly-owned subsidiary of Zhejiang Provincial Energy Group Co., Ltd. The equity interest in Zhejiang Provincial Energy Group Co., Ltd. is held as to 90% by the State-owned Assets Supervision and Administration Commission of the People's Government of Zhejiang Province and as to 10% by Zhejiang Provincial Department of Finance.
